## Artificial Intelligence & Biometric Technologies

## Summary

The bill establishes an artificial intelligence impact task force to study AI and biometric technologies, focusing on ethical practices and facial recognition issues.

## Business Impact

If you use AI or biometric technologies in Colorado, you must comply with new ethical guidelines by February 1, 2025, or face regulatory scrutiny.

## Key Provisions

- Creation of an artificial intelligence impact task force with 26 members.
- Task force to study ethical and equitable impacts of AI and biometric technologies, including facial recognition services.
- Report due by February 1, 2025, summarizing findings and recommendations.
- Task force to meet at least five times before submitting the report.
- Task force scheduled for repeal on September 1, 2027.

## Compliance Checklist

- Participate in task force meetings and provide input on AI regulations. | Who: Members of the artificial intelligence impact task force. | Penalty: N/A; participation is required for task force members.
- Implement recommendations from the task force once published. | Who: Businesses and organizations using AI and biometric technologies. | Penalty: Potential regulatory scrutiny for non-compliance.
