## Summary

SB0005 establishes consumer data protection laws in Indiana, effective January 1, 2026, detailing consumer rights and controller responsibilities.

## Business Impact

If you control consumer data in Indiana, you must comply with new data protection laws by January 1, 2026.

## Key Provisions

- Definitions of terms related to consumer data protection.
- Exemptions for certain data controllers.
- Consumer rights to confirm, correct, delete, and obtain personal data.
- Responsibilities of data controllers, including data protection impact assessments.
- Requirements for processing de-identified or pseudonymous data.
- Authority of the attorney general to investigate and enforce the law.
- Preemption of local laws on personal data processing.

## Compliance Checklist

- Ensure consumer data processing practices comply with new rights and responsibilities. | Who: Data controllers operating in Indiana. | Penalty: Potential enforcement actions by the attorney general.
- Conduct data protection impact assessments as required. | Who: Data controllers. | Penalty: Potential enforcement actions for non-compliance.
