Summary

HB5143 amends Michigan's 1976 PA 388 to define 'artificial intelligence' and is contingent on HB 5141 becoming law.

Business Impact

If you use AI in campaigns, note the new definition effective February 13, 2024.

Key Provisions

- Defines 'artificial intelligence' in Section 2 of 1976 PA 388 (MCL 169.202).
- Tie-barred with HB 5141, requiring its enactment for HB5143 to take effect.

Compliance Checklist

- Ensure AI systems used in campaigns comply with new definitions. | Who: Political campaigns using AI in Michigan. | Penalty: Potential legal issues for non-compliance.
